I placed this item on the workshop agenda to discuss where Lexington sits in comparison with Circle Pines and Centerville regarding our police call volume in the year 2021. I included previous year's call volume statistic so that you can see how much our police events are increasing along with our increasing population.

As a general reminder, our annual call volume and population directly affects the City of Lexington's obligation to the Centennial Lakes Police budget. I wanted to have this discussion with the City Council to prep you for the 2023 budget process so that there are not any surprises.
