**Cut back on Road Salt to Protect Our Infrastructure,
Water, and Aquatic Wildlife!**

The Twin Cities Metro applies 350,000 tons of road salt every year, but have you ever wondered where it goes when winter ends?

Stormwater and snowmelt carry dissolved road salt into lakes, streams, and groundwater when winter thaws out. Chloride, a major part of road salt compounds, is especially stubborn in water. Once it dissolves, there is no feasible method to remove chloride from water, and stormwater treatment solutions like stormwater ponds and rain gardens are ineffective at removing chloride. Instead, chloride gradually accumulates in our water bodies, harming fish and other aquatic life. The corrosive nature of road salt also contributes between \$350 million and \$1.2 billion in infrastructure costs each year to the Metro area alone.

What can you do about it?

Here are some helpful tips you can use to make your driveways and sidewalks safer and better for the environment this winter:

Shovel!

Salt is never a substitute for shoveling. Shovel your snow and ice first so that salt is only used for melting ice stuck to the ground.

Scatter!


Did you know you only need a 12-oz. mug of salt to effectively de-ice a 20-foot driveway or 10 sidewalk squares? When applying salt, aim to leave 3" between grains.

Salt!

Traditional salt (sodium chloride) does not melt ice when the temperature is below 15 degrees Fahrenheit. Use a low-temperature alternative such as magnesium chloride or calcium chloride to melt ice at lower temperatures or use sand for traction.

Sweep!

Sweeping up leftover salt and reusing it later is a great way to save money and limit the amount of salt getting into nearby waterways

WINTER PARKING RESTRICTIONS

**Parking restrictions are in effect and go
until April 1st.**

*****No Parking** allowed on City streets between the hours of 2 AM and 6 AM without an emergency parking permit issued by staff at City Hall.

*****No Parking** on any street after a snowfall with accumulations of 2 inches or more until all snow, ice and similar debris have been removed from the paved portion of the street.

***** It is illegal** to remove snow from private property and place it on the road or sidewalk.

*****Approximately 200 accidents** occur each year involving snow moving equipment, so be extra cautious and **always** give the plow truck the benefit of the doubt.

Do you own a Business or Rental Property in the city of Lexington?

City ordinance requires that all businesses & rental properties obtain a license to operate within the city limits.

Business licenses must be renewed yearly by June 30th.

Rental properties are licensed on a biennial basis from the date of your 1st application. They also require an inspection of the property be done with each renewal.


Make sure your **Garbage Carts** are placed behind the curb and not in the street. This will help to avoid them being hit by the plow .

Recycle Small Electronics Safely in Anoka County

Do you have old cell phones, video game consoles, or small electronics collecting dust at home? Don't toss them in the trash—recycle them responsibly! Many small electronics contain batteries that can pose serious fire risks if punctured or crushed in the waste stream. Proper disposal helps protect our environment and community.



There are many convenient drop-off locations for recycling small electronics, including battery-enclosed items like cell phones. These facilities ensure safe handling and proper recycling of materials, keeping hazardous components out of landfills.

To find a nearby drop-off site, visit the **Anoka County Recycling Directory** at AnokaCountyMN.gov/recycling directory. The directory provides detailed information on where and how to recycle various items, including electronics, games, and more. You can also check with your city's recycling department for additional local options.

Materials Accepted:

- Appliances (\$10 - 25 each)
- Batteries: sealed lead acid, small household and rechargeable (\$0 - \$6.50/lb)
- Carpet: no rubber back (\$6/roll)
- Electronics
 - Printers, scanners and fax machines (\$10 - 35 each)
 - Hard drive destruction (\$5 each)
 - TVs and monitors: all sizes (\$18 - 85 each)
 - Small and medium items: mice, keyboards, DVD and VCR players, stereos, speakers, record players, coffee makers, toasters, toaster ovens, keyboards, vacuums, phones, small appliances and video game consoles (\$0 - 5 each)
- Exercise equipment (\$25 - 40)
- Fluorescent bulbs (\$.50 - .95 each)
- Holiday lights (FREE)
- Mattresses and box springs (\$20 - 25 each)
- Paper shredding: 2 box maximum, no 3-ring binders or newspaper (FREE)
- Propane tanks (\$5 - 20)
- Scrap metal: clean and all non-metal material removed (FREE)
- Tires (\$7 - 9 each)



Before recycling, consider donating working electronics to local charities or reuse organizations. Many groups accept gently used devices to support community programs or help those in need.

By recycling and donating responsibly, you're helping reduce waste, conserve valuable resources, and prevent dangerous fires. Let's work together to keep Anoka County safe!

Prices have a range since they vary by the size and type of material.

Can I recycle my delivery PIZZA BOX?

To go/delivery pizza boxes, if the top of the box is clean and the bottom is greasy, tear the top off and recycle that. If you are signed up for the Anoka County organics program, the greasy bottom can be composted, make sure all stickers or plastic/waxy liners are removed.
